This Dog Boarding Contract (the "Contract") is entered into between Hillside RSA Boarding, hereinafter referred to as the "Boarding Facility," and the pet owner, hereinafter referred to as the "Owner."

Services Provided:

The Boarding Facility agrees to provide boarding services for the Owner's dog(s) as detailed in the services selected by the Owner on the intake form. Services may include accommodation, feeding, medication administration, and additional services as agreed upon.

Health and Vaccinations:

The Owner certifies that their dog(s) is in good health and has received up-to-date vaccinations, including rabies, distemper/parvo, and bordetella (kennel cough). The Owner agrees to provide documentation of vaccinations upon request.

Fees and Payments:

The Owner agrees to pay the fees associated with the selected boarding services. Payment is due in full upon the dog's check-in. Additional charges may apply for requested services not included in the standard boarding package.

Emergency Veterinary Care:

In the event of illness or injury, the Boarding Facility is authorized to seek veterinary care for the dog(s). The Owner agrees to cover any associated veterinary costs and acknowledges that the Boarding Facility will make a reasonable effort to contact them in such situations.

Liability and Release:

The Owner acknowledges that dogs may exhibit unpredictable behavior, and the Boarding Facility will not be held liable for injuries or damages caused by the Owner's dog(s) during their stay. The Owner agrees to assume full responsibility for any harm or damage caused by their dog(s).

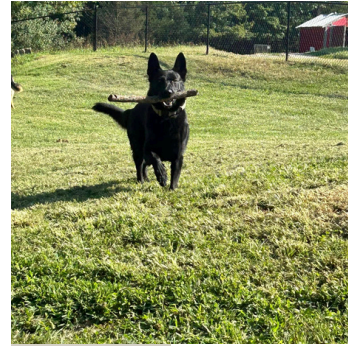

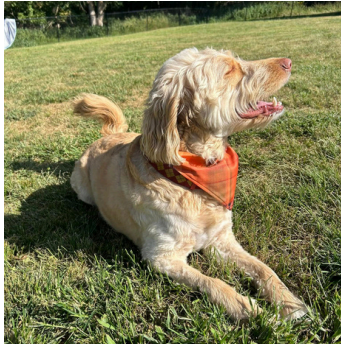
